### ORDER

- Whereas, Re-Survey work of the (1) Falandi, (2) Galonda, (3) Kilvani, (4) Silli, (5) 1 Umarkui villages of Kilvani Patelad completed & Preparation of New land record has been completed for the said village under "Digital Land Record Modernization Programme (DILRMP) earlier knows as NILRMP. Survey started on 15/09/2016 in (1) Falandi, (2) Galonda, (3) Kilvani, (4) Silli, (5) Umarkui, villages of Kilvani Patelad, LPM (Land Parcel Map) distribution started on 01/10/2017 & total 81 objections received against LPM, objection hearing done on 10/09/2019 by Survey & settlement officer, Silvassa. New Resurvey record prepared after Quality Check process.
- Now, therefore, in pursuance of Collector-DNH. Silvassa's order dated-20/06/2018 referred to in preamble (2) above and in pursuance of provision contained under Section-73 (read with 21), Section-77, 80 & 81 of the DNH. Land Revenue Administration Regulation, 1971, the new survey record is now promulgated for new survey number from 1 to 496 for Falandi village, New survey number from 1 to 314 for Kilvani village, New survey number from 1 to 2180 for Galonda village, New survey number from 1 to 2535 for Silli village, New survey number from 1 to 1081 for Umarkui village.
- After Promulgation, the format of the Village Form 7 x 12 will be changed / modified. If any technical / clerical error will be found, same will be treated under Section-240 of the DNH Land Revenue Administration Regulation, 1971.
- The un-numbered area (i.e. Road, Kotar, Gamtal, River etc.) will also be assigned new Survey number and New Village Form number 7 x 12.
